


Figure 1 Principal Dr Kiran Rakibe Guided the students.




Figure 2 Mr. Abhijit Pavse (Sales Executive) Delivered the Lecture.








Figure 1 Principal Dr Kiran Rakibe Guided the students.





Figure 3 Candidates attended drive.
