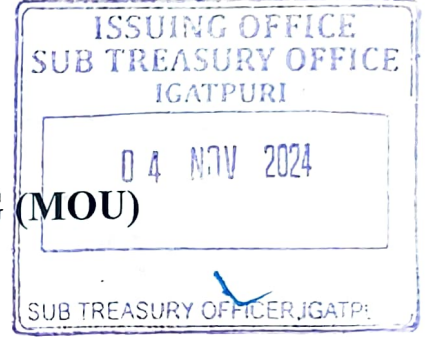

**CLAUSE 1
CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives. They shall establish channels of communication and co-operation that will promote and advance their respective operations within the, and its related wings. The Parties shall keep each other informed of potential opportunities and share all information relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party, providing significant inputs to them in developing suitable teaching/training systems, keeping in mind the needs of the vocational education the Second Party.

CLAUSE 2
SCOPE OF THE MoU

2.1 Both parties believe that close co-operation between the two would be of significant benefit to the student community to enhance their skills and knowledge.

2.2 Curriculum Design: Second Party will give valuable inputs to the First Party in teaching/training/ methodology and suitably customize the curriculum so that the students fit into the skill education and get job opportunities in various fields.

2.3 Training & Visits: Institution interaction will give an insight into the latest developments/requirements of the skill education/skill development; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Training Programs for the First Party. The training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, pledge the other Party's credit, or extend credit on behalf of the other Party.


